Mrs. Yanakany Valdez stated that the separate attachment in the board packet shows that Mr. Leslie Hayenga is maintaining a log to reflect the reimbursements, once approved, from E-Rate.
- F8. Consideration to approve Purchase Order over \$25,000.00 with Weaver Technologies in the amount of \$78,691.20 for wireless fiber and computers at CTE High School. Mrs. Yanakany Valdez stated that the separate attachment included in the board packet shows that Mr. Leslie Hayenga is maintaining a log to reflect the reimbursements, once approved, from E-Rate.
- F9. Consideration to approve Purchase Order over \$25,000.00 with John S. Graves & Associates, INC. Architects in the amount of \$55,250.00 for architectural services for the Laughlin Magnet School.

Mrs. Yanakany Valdez responded by stating VST Services have been used since 2009-2010 fiscal year and that Mr. Rus O'Neil has provided assistance and guidance with the E-Rate process and that the district has continually received reimbursements for long distance, internet, and local phone service; and this is included in the general fund revenue and averages approximately \$150,000.00 yearly. Mrs. Valdez also explained that this contract is for E-Rate reimbursable services and in August the district will submit commitments for E-Rate so that the district can commit their portion in order to qualify for the reimbursements from E-Rate, and that this would be a separate contract for those E-Rate services.
- Mr. Raymond Meza questioned the following items:

Mr. Meza requested assurance that this would be a custom built dashboard since SchoolNet was unable to provide the service. Mrs. Aidee Garcia stated yes, this is a curriculum repository and they are customizing a data repository for the district.
- G4. Consideration to approve Contract over \$5,000.00 with the Texas Center for District and School Support (TCDSS) at Education Service Center Region XIII in the amount of \$10,560.00 for consulting services. Mr. Raymond Meza asked what this item was and clarification of consulting services. Dr. Carlos Rios responded by stating that part of a grant award at Del Rio Middle School included the first phase of strategic planning and the second phase of strategic planning, which is regarding the marquee programs, was not covered by the grant. This was something the district has already committed to doing by reviewing these programs and that ESC Region XIII started the process so the district will continue with them. The Strategic Plan will be presented for board approval once this phase is completed.
