BOARD RESOLUTION OF SAN FELIPE-DEL RIO CONSOLIDATED INDEPENDENT SCHOOL DISTRICT

WHEREAS, the San Felipe Del Rio Consolidated Independent School District (the "District") is generally prohibited from expending public funds for the benefit of an individual; and

WHEREAS, the District is authorized by Education Code section 45.105(c) to utilize public funds for purposes necessary in the conduct of the public schools; and

WHEREAS, the Board recognizes that the District was closed unexpectedly for 5 days from February 15, 2021 thru February 19, 2021, due to a severe winter weather storm, causing employees to miss work due to the unexpected school closure; and

WHEREAS, the Board has determined that the expenditure of school funds in order to pay District employees due to such unexpected closure is necessary in the conduct of the District's public schools in that such payments will benefit the District by increasing employee morale and reducing employee turnover, thereby assisting the District in furthering its educational mission;

NOW, THEREFORE, be it resolved that the District pay employees scheduled to have worked from February 15, 2021 thru February 19, 2021, but who were prevented from working due to the unexpected school closure, their regular wage payments for the hours in which they were expected to have worked from February 15, 2021 thru February 19, 2021, according to each employee's regular work schedule.

NOW, THEREFORE, be it further resolved, pursuant to Education Code section 45.105(c) authorizing the expenditure of public funds for purposes that are found by this governing board to be necessary in the conduct of the public schools as furthering this District's educational mission.
