### RESOLUTION TO CONSIDER DESIGNATION AS DISTRICT OF INNOVATION

**WHEREAS**, THE 84<sup>TH</sup> Legislature passed House Bill 1842 which provides Texas public school districts the opportunity to be designated as Districts of Innovation; and

**WHEREAS**, Texas school districts designated as Districts of Innovation may be exempted from a number of state laws which affords traditional public schools with many of the same freedoms that apply to open-enrollment charter schools; and

WHEREAS, Education Code 12A.001 provides that a district is eligible for designation as a district of innovation if the district's most recent performance rating under Section 39.054 reflects at least acceptable performance, and that consideration of designation as a district of innovation may be initiated by a resolution adopted by the board of trustees of the district; and

**WHEREAS**, the San Felipe Del Rio Consolidated Independent School District's most recent performance rating under Education Code 39.054 reflects at least acceptable performance.

**NOW THEREFORE BE IT RESOLVED**, that the San Felipe Del Rio Consolidated Independent Board of Trustees by adoption of this resolution initiates the process under Education Code Chapter 12A to become a District of Innovation; and,

BE IT FURTHER RESOLVED, that after this resolution is signed by the Board, a public hearing shall be held within 30 days to consider whether the District should develop a local innovation plan for the designation of the District as a district of innovation and that within 30 days of the public hearing the Board of Trustees of San Felipe Del Rio Consolidated Independent School District shall appoint an innovation plan committee to develop a local innovation plan or decline to pursue designation as a district of innovation.
