REPORTS

A. COVID-19 / School Closure (Dr. Carlos Rios)

Dr. Carlos Rios presented an update regarding the COVID-19 and school closure. He stated that the Governor has directed that school remain closed, but that the home based instructional program continue. Therefore, the home based instructional program will continue thru the end of the school year, as well as serving meals. In addition, Dr. Rios stated that this past six-weeks a total of 5,719 grades are recorded

as incomplete, but noted that this can be one student with six incompletes and incompletes equal to an "F". The count of incompletes for the previous six-weeks were only 1,656 and the third six-weeks were only 1,707. These incompletes will become identifications for summer school and students need to complete their work and the expectation is that grades continue and students will fail the class. Dr. Rios stated that administration knows the situation is difficult and administration will do all that is possible to continue to provide the opportunity for the students to complete the courses over the summer, but it will be an "F" once the school year is over. Students will have the opportunity to switch the "F" to a passing grade, but they will have to continue to work over the summer. It is a larger number of failing grades and the report shared with the Board of Trustees is for grades $8^{th} - 12^{th}$.

In addition, Dr. Rios stated that the County Judge reported that the executive order was going to expire April 20, 2020, but he was going to re-issue the executive order with some modifications. Lastly, district employees continue to work from home and incentive pay is being applied to those that are required to report to work, which is mostly bus drivers, food service workers and security, as well as limited professionals and paraprofessionals. Dr. Rios emphasized to parents that students not completing their assignments will be getting failing grades and will not get a free pass for the semester and that the district is willing to work with them during the summer, but they cannot use the excuse that they were in crisis.

There was discussion regarding the Commissioner of Education's upcoming conference calls with superintendents, possible comparison of number of incompletes with other districts, clarification that there will not be accountability and ratings this year, clarification regarding the ECHS dual-credit grades and incompletes reported, clarification regarding counselors reaching out to staff at junior college, possible comparison regarding report of incompletions and mailed lessons, clarification if the previous six-weeks students are included in the current report, clarification regarding online and mailed lessons, clarification on count of seniors on last report, and clarification regarding teachers inputting the zero grade or incomplete.

ADMINISTRATION

A. Consider and Take Possible Action on a Resolution to Determine 2020 Spring Semester Grading Policy, GPA's for the Spring 2020 Semester for the 2019-2020 thru 2023-2024 Class Cohorts, and Class Rank for the Class of 2020.

(Dr. Carlos Rios)

Recommended Action: Discussion

Dr. Carlos Rios began the discussion by stating that Superintendents have been provided with a checklist by the Commissioner of Education during this particular time of the pandemic. Among the items that need to be addressed includes the identification of a grading process for the second semester and the determination of how the district will calculate grade point averages. Dr. Rios pointed out that this determination has only to do with the classes that go on the high school graduation transcript. He added that the Administration has started looking at all the pros and cons, and has considered grading assignments through the end of the school year and having them count towards their GPA. The Administration considered one option of having grades calculated solely through the first semester towards the GPA, and another option of calculating grades through the fourth six-weeks on the GPA. The students in the 2019-2020 thru 2023-2024 class cohorts would receive a numerical grade for the Spring 2020 semester; however, for GPA purposes, the grades would be recorded as pass/fail. Dr. Rios further explained that there has been a whole lot of discussions on this topic, in particular with the high school principals; and it is on this basis of this discussion that they are making the specific recommendation to calculate grades through the fourth six-weeks.

Mr. Overfelt expressed that there is difficulty with the decision to go with the fourth six-weeks option because school is still in session. Mr. Overfelt also stated that another concern is with the calculation of grades for dual-credit classes. He explained that colleges do not give classes by six weeks. "Anybody taking a dual-credit course would not have a grade for the fourth six-weeks. So counting the GPA through the fourth six-weeks immediately is problematic and almost impossible because not everyone would have a grade. The other option was counting grades all the way through the school year, and the difficulty with that process is that there are a lot of classes being taken right now where students are having to work extremely difficult to earn their B, C or in some cases an A in dual-credit classes that are weighted and would count towards their GPA." Mr. Overfelt added that there are also another number of classes that because of distance learning, it's difficult to replicate the rigor. He further stated that this grading system would have implications for all students taking dual-credit classes noting issues with calculating grades for courses that are weighted and not weighted, and would affect more people in a negative way than in a positive way.

Dr. Rios stated that the Administration is having a difficult time recommending that this semester's grades count towards GPA weights, not only for this senior class, but for all classes that will follow. He indicated that a small study was held to look at what the implications would be for grades being equal, whether the grades in this year's ranking would affect the top ten percent when counted towards the GPA. Dr. Rios stated that they didn't see any major shift in the top ten percent overall, which meant that the GPA would stay the same. Dr. Rios also stated that if the Administration were to

introduce a variation in grades, it would negatively affect a whole lot more students than it would help. He added that given the circumstances, "the safest recommendation would be to fail students that don't turn in their work, and to pass those that do turn in their work; assign a numerical grade to their transcript that the NCAA or some other educational institution can use. But for our purposes, not count it towards the GPA class ranking for this semester's senior class and in the future."

There was discussion regarding GPAs and dual-credit courses and grades, and a request for Dr. Rios to further discuss this item with other superintendents. There was clarification regarding incomplete grades and a teacher's ability to change grades due to incoming assignments, a request for the Administration to place an emphasis on those students, and advising them that failing to turn in lessons will result in failing grades and the need to attend summer school, credit recovery. There was a request for parent input on this issue.
