Exhibit B—Resolution of the Board to Allow Teaching in Lieu of Tax Payment on a Residence Homestead

WHEREAS, Section 31.036 of the Texas Tax Code authorizes the Board of Trustees of _____ School District to permit qualified individuals, as defined in Tax Code 31.036(h), to perform teaching services at a junior or senior high school of the District in lieu of paying taxes imposed by the District on property owned and occupied by the individual as a residence homestead; and

WHEREAS, any qualified individual will agree to execute a contract with the District following the requirements of Section 31.036 of the Texas Tax Code;

Exhibit C—Resolution of the Board to Allow Teaching in Lieu of Tax Payment on a Business-Owned Property

WHEREAS, Section 31.037 of the Texas Tax Code authorizes the Board of Trustees of _____ School District to allow a qualified individual, as defined in Tax Code 31.037(i), employed by a business entity to perform teaching services at a junior or senior high school of the District in lieu of paying taxes imposed by the District on property owned by the business entity; and

WHEREAS, any qualified business entity will agree to execute a contract with the District following the requirements of Section 31.037 of the Texas Tax Code;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of _____ School District will permit any qualified business entity to assign a qualified employee to perform teaching services for the District during the 20__—__ school year in lieu of paying property taxes to the District in compliance with Section 31.037 of the Texas Tax Code, subject to any limitations established by the Board under Tax Code 31.037(b).
