not able to pay for insurance and current discussion of district ability to pay for a stipend to cover insurance, normal wage increase this year, clarification of cost savings if stop loss discontinued, concern over catastrophic event and the impact on insurance without stop loss, clarification of wind farm incentive, and multi-year plan.
