SAN FELIPE DEL RIO CONSOLIDATED INDEPENDENT SCHOOL DISTRICT BOARD RESOLUTION

ENCOURAGING GOVERNOR GREG ABBOTT TO CALL A SPECIAL SESSION TO PROTECT OUR SCHOOLS FROM MASS SHOOTINGS

WHEREAS, the 2022 Spring semester ended in a state-wide tragedy with the mass shooting at Robb Elementary in Uvalde, Texas, leading to the loss of 19 children and 2 teachers:

WHEREAS, our nation has a long list of mass shootings, to include the Midland-Odessa shooting, the El Paso Walmart shooting, the Santa Fe High School shooting and the Sutherland Springs Church shooting, all occurring in Texas within the past 5 years;

WHEREAS, our students, parents, faculty and staff should not be in fear that mass shootings and gun violence will occur within SFDRCISD and our community, as our schools must be a safe refuge for our children and the adults charged with their care:

WHEREAS, the Texas Legislature can take action to protect our children from mass shootings and senseless gun violence by implementing common sense reforms that focus on our children's safety and security wherever they gather, be it our schools, churches and houses of worship, and other public places:

WHEREAS, the Texas Constitution requires the Governor to call the Texas Legislature into Special Session, and although three special sessions have been called since the end of the 87th Regular Session on May 31, 2021, none of these focused on the prevention of mass shootings and gun violence.

NOW, THEREFORE, BE IT RESOLVED,

THAT the Board of Trustees of the San Felipe Del Rio Consolidated Independent School District calls upon Governor Abbott to call a special session of the Texas Legislature as soon as possible to protect our children from mass shootings and gun violence; and

THAT the Board of Trustees of the San Felipe Del Rio Consolidated Independent School District calls upon the Governor to include common sense policies, such as raising the minimum age for the purchase of assault rifles, in order to protect our most precious Texas resource, our children.
