# Regular School Board Meeting April 21, 2014

Minutes of the Regular School Board Meeting of the Board of Trustees of the San Felipe Del Rio Consolidated Independent School District held Monday, April 21, 2014, in the Administrative Office Board Room, 205 Memorial Drive, Del Rio, Texas.

The meeting opened at 6:04 p.m.

Charles A. Garabedian determined that with six members in attendance, a quorum was present, confirmed by Joshua D. Overfelt.

Mr. Raymond Meza asked for a few minutes of silence for the students of Hindu South Korea that lost their lives recently in a ferry accident.

Mr. Joshua Overfelt asked for a few minutes of silence for Mr. Fred Langford, former aircraft maintenance instructor that passed away recently.

A few minutes of silence was observed for personal reflection.

The Pledge of Allegiance to the Flag of the United States of America was given.

### RECOGNITIONS

A. Del Rio High School Exemplary Migrant Students - Michele Smith and Olalla Gonzalez

Mrs. Michele Smith gave a brief presentation of the Migrant Student Enhancement Program and ceremony that was recently held. Martin Ibarra of Del Rio High School was selected as a 2014 Exemplary Migrant Student for his exemplary academic achievements. The Board of Trustees and members of the audience recognized Martin and his parents, Marco and Josefa Ibarra.

 B. FTC (First Technical Challenge) Off-Season Event Award of \$8,000.00 – Abelardo Casillas and Roger Gonzalez

This item was not presented at this meeting, but will be presented at a later date.

C. Career and Technical Education (CTE) Recognition of Students Advancing to National and World Competitions – Roger Gonzalez

Mr. Roger Gonzalez and CTE Sponsors of FBLA, Welding Program, and Robotics FRC Team 4063 presented to the Board of Trustees and members of the audience, the students of three CTE Student Organizations that earned an opportunity to advance to National and World Competition Events.

- Del Rio High School Chapter of Future Business Leaders of America (FBLA) competed at the Texas FBLA State Leadership Conference in Corpus Christi, Texas on March 13-15, 2014 by earning the top places in their respective events, these students qualified to represent the State of Texas at the FBLA National Competition to be held June 27-July 3, 2014 in Nashville, Tennessee.
- CTE students enrolled in the Del Rio High School Welding Program competed and placed at the District Skills USA events in San Antonio in February and advanced to the State Competition in Corpus Christi, Texas on March26-29, 2014. Students in the Welding Team Fabrication Team are advancing to the Skills USA National Competition to be held June 23-27, 2014 in Kansas City, Missouri.
- Del Rio High School Robotics FRC Team 4063 competed in three regional tournaments winning different awards in each competitions. The team earned the right to compete at the FIRST (For Inspiration and Recognition of Science and Technology) World Championship for the second straight year by winning the Engineering Inspiration Award at the HUB City Regional Competition held on March 5-8, 2014 in Lubbock, Texas. Students will be traveling to the World Championship in St. Louis, Missouri from April 22-26, 2014.
- D. Secondary Science Fair Regional and State Results Patricia Brown

Mrs. Patricia Brown presented to the Board of Trustees and members of the audience the winners of the 2014 Alamo Regional Science and Engineering Fair held on March 3-4, 2014. Fifty-five students of Del Rio competed, of those, eighteen placed or received special awards.

E. Del Rio High School Air Force JROTC TX-066 Recognition – Lt. Col. Simon P. Benavides

Lt. Col. Simon P. Benavides presented to the Board of Trustees and members of the audience a brief update of the Del Rio High School Air Force JROTC TX-066, which is a cadet run corp. The Del Rio High School Air Force JROTC TX-066 competed and placed 2<sup>nd</sup> in Armed Inspection and 3<sup>rd</sup> in Unarmed Inspection at the Texas Tech University Drill Meet. The Color Guard has posted the colors at 20 different school and community events, as well as the cadets having accumulated over 2,700 hours of community service.

F. Fine Arts UIL Solo and Ensemble, and VASE Results - Juan Nanez

Mr. Juan Nanez, Mr. Josue Gonzalez, Mrs. Catherine Calvetti, and Mr. Chris Escobar presented to the Board of Trustees and members of the audience the following:

 The Del Rio High School Choir under the direction of Mr. Josue Gonzalez participated in the UIL Solo and Ensemble competition on March 7, 2014. The students acquired 20 - 1<sup>st</sup> Division Solo medals and also had one ensemble receive a 1<sup>st</sup> Division. Eleven students and one ensemble will be advancing to State competition on May 24<sup>th</sup>, 2014.

 The Del Rio Freshman School Visual Arts under the direction of Mrs. Catherine Calvetti participated in VASE Visual Arts Scholastic Event competition and had seven students with the top score of 4 for a Division 1.

 The Del Rio High School Visual Arts under the direction of Mr. Chris Escobar participated in VASE Visual Arts Scholastic Event and had eleven students receive the highest medal ratings of 4, which is the level before reaching State. Elizabeth Alkins advanced to the State VASE Competition which was held April 4-5 in Bryan, Texas. Elizabeth received a Superior Exemplary Ratings (Level IV).

Mr. Joshua Overfelt stated the recognitions presented today show the district has the greatest students in the state of Texas and is proud to represent the district.

## **Board Members' Report**

A. National Youth Week: County Government (Uvalde ISD) - Charles A. Garabedian

Mr. Charles Garabedian commented on the National Youth Week County Government in Uvalde CISD. The Uvalde CISD has been participating in this event for about 24 years, in observance of National Youth Week. Some top Uvalde High School students serve as mock local officials and this is done through a multi-step process for eligible Juniors and Seniors based on their grades and their records. They are eligible to enter an election and if they get elected to the post, they spend the day shadowed by the official of that position. There are also a number of appointed county positions that the students apply for as well. The Uvalde Lions Club has a committee that selects these students. This is something that engages the students in civic activity and may be something the board would like to look into this.

B. Update on the implementation of House Bill 5, Community and Student Engagement Committees – Cecilia Martinez-Lozano and Amy Haynes

Mrs. Cecilia Martinez-Lozano requested that Dr. Rios give an update of the Community Engagement Committee, because as she understands, the district has to report to the State by August 8, 2014 for the 2013-2014 school year as it relates to the Community Engagement rating.

Dr. Carlos H. Rios stated this was started earlier this semester and Dr. Garza has attended a couple of workshops to ensure the district had all the information and started working the process through the district site-based committee. There are different components that the district has to be evaluated on and there needs to be guidance to it. The committee started working matrices that will be used to evaluate where the district stands. Due to HB 5 being heavily weighted with CTE and the endorsements, Mr. Gonzalez will nominate 7 individuals, the board will nominate 14 individuals, 2 each. Once the matrices are set, they will be presented to a larger committee for feedback and approval. The committee established, which will consist of board nominations, Mr. Gonzalez' seven members, a teacher from each campus and a student representative will evaluate the district and give the final rating. Most of

the work will be done in June so the district will meet the timeline.

Mrs. Martinez-Lozano stated that many districts are working with committees they have already established, kind of like what we are doing with Mr. Goznalez with his CTE committee. As the years go on Mrs. Martinez-Lozano would envision that the committee would become more specific to those 9 factors to include the fine arts, wellness and physical education, community and parental involvement, 21st Century Workforce Development, Second Language Acquisition, Digital Learning Environment, Dropout prevention Strategies, and educational programs for Gifted and Talented Students compliance policy reporting requirements. According to HB 5, as it relates to the community engagement rating those 7 factors plus the last item requirements should be incorporated into committees.

Dr. Rios stated, once the larger committee is established, they will then break off into sub committees and each one will take one of those areas to complete the matrices and give recommendations. As the years go on he envisions seeing a larger committee for each one of the areas that are mentioned and as an example, the bilingual area - get the bilingual department to select more parents to form that committee. As we go on we can only improve on it.

### C. Texas Lone Star, Vol. 32, Number 3, April 2014 - Charles A. Garabedian

## 1. "Dip in New Teacher Supply Could Cause Hiring Headaches"

Mr. Charles Garabedian stated we are getting to the end of the academic year and for the board there is upcoming training in the Summer so there are some things to be on the lookout for, and hopefully bring back to share. Garabedian further stated he was struck by some articles in the Texas Lonestar, Vol. 32, Number 3, April 2014. One article is "Dip in New Teacher Supply Could Cause Hiring Headaches", this article shows a five year trend of the production, this is state wide, of educators' certificates and their employment in Texas. What it's pointing out is that there is a large scale trend of a drop and how districts across the state are trying to deal with it, struggling with it, which seems to be the common thread. It's rather sobering to see over that 5 year time period how it's dropped from a certain percentage to many percentage points lower and how it's affected certain high risk areas and high need areas. Those are things this district is struggling with as well, but it's not a localized problem as the Texas Lone Star magazine points out. It sites information from not only TASB but also from the Texas Education Agency. It mentions surveys that have been conducted and talking about other things that have impacted teachers relative to a district's ability to recruit teachers, including job satisfaction which is also a concern across the state and feels it was something that as we begin to plan our training and conference activities in the near future, to be more mindful of.

## 2. "Speaker Posts Interim Charges for Public Ed Committee"

Mr. Garabedian then spoke of the article "Speaker Posts Interim Charges for Public Ed Committee", this article touches on something that Ms. Haynes and Mrs. Martinez-Lozano brought up last month. This is in regard to speaker of the house Joe Straus in San Antonio releasing his interim charges for the

house committee and was struck by this also being a larger agenda. Ms. Haynes and Ms. Martinez-Lozano had talked about board effectiveness and assessing the board's role, this is something that apparently the speaker is pushing as well, talking about the traits and characteristics of good governance, effective checks and balances between the board and the administration, effective relationship between the board and the superintendent in the oversight authority like TEA. This is something Mr. Garabedian is going to look more into because it was a concern of both Ms. Haynes and Mrs. Martinez-Lozano, and being struck again by the fact that this is part of a larger initiative.

3. "Average Texas Teacher Salary Climbs Almost 3 percent"

Mr. Garabedian stated we are at the beginning as a board of the budget process and there are 4 budget workshops to look forward to this year and would hope that an article like this, which is talking about how salaries are on the rise in some districts and trying to be competitive with the real fact that there is a teacher shortage and a certification gap across the state, what different districts are doing. Mr. Garabedian is also mindful of the fact that 2 years ago there was a TASB salary study that was undertaken by this district, and only parts of it were used and since it's an ongoing process in improvement, it is certainly time to look at that again. There have been changes in Eagle Pass for beginning teacher salaries and what the steps are. Mr. Garabedian would like more clarification about percentage of salary increases from what was talked about from one year to the next. All board members are very strong teacher advocates and pay is a key component to finding and keeping good teachers, so Mr. Garabedian thought that this was a relevant article, especially moving into the TASB training and conferences and especially at budget time.

#### REPORTS

A. Buena Vista Elementary Gym Project Update - Dennis Dunlap and David Brown

Mr. Dennis Dunlap and Mr. David Brown presented to the Board of Trustees and members of the audience the following:

- On the exterior masonry and plaster work are on-going. Preparations for installation of the metal wall panels are being made.
- Roofing work is essentially complete with the exception of metal copings and completion of gravel. The building is dried in.
- The south porch is essentially complete and the drainage structures between the new and existing buildings are in progress.
- Color selections have been approved and a final court layout has been approved.
- Mechanical, electrical and plumbing rough-in is on-going and being properly coordinated by the Contractor.
- The project is on schedule. All parties are working to allow installation of the City required fire lane to occur prior to the school year ending. This will allow the contractor to concentrate on the completion of the building and site tasks as

was originally planned. The current completion date remains unchanged at July 5, 2014.

### D. District Security and Safety Update - John A. Sheedy

Mr. John Sheedy presented to the Board of Trustees and members of the audience a brief update of the 2013-2014 Multi-Hazard Emergency Operations Plan for all campuses and a Summary Report. The plans will be updated during the Summer Break and distributed to principals who will then update for campus distribution. The shift in focus will now be in plans, documentation, training and working with the plans.

There was discussion regarding the great job of the completed Emergency Operations Plan, planning, different sirens and strobes indicating the different warning alarms, hearing impaired and deaf unit flashing lights/strobes, connection of all buildings to main alarm system at campuses, follow-up meeting with Sentry Security and further update to the board.

### E. Discipline Report - Mrs. Aidee Garcia

Dr. Carlos H. Rios indicated to the Board of Trustees that the discipline report was included in the board communique and asked if there were any questions. There were none.

### F. Attendance Report - Dr. Jorge Garza

Mr. Charles Garabedian indicated to the Board of Trustees that the attendance report was included in the board communique and asked if there were any questions.

Dr. Carlos H. Rios added that administration continues to be concerned with attendance and has asked Mrs. Yanakany Valdez to secure training on evaluating the data that can more closely pinpoint where the district needs to look so that data can be used to anchor a fresh view as to how the district is going to improve attendance. Administration recognizes that yes, attendance may be above 96% but our goal is 98% and fluctuating up and down does not help us get to our goal. Dr. Rios will provide the board an update of the data and pinpoint areas to improve upon.

## G. Report on Benchmark Testing – Dr. Jorge Garza

Dr. Jorge Garza reported to the Board of Trustees and members of the audience, district benchmark assessment data that was extracted from DMAC.

There was discussion regarding projection for two questions, benchmark percentages include everyone taking the tests, campus growth and accountability, Spanish benchmark testing.

## H. Technology Update – Abelarado Casillas

Mr. Abelardo Casillas, Dr. Jorge Garza, Mrs. Libby Milender, and Mrs. Yanakany Valdez reported to the Board of Trustees and members of the audience, the district technology update to include a few recent highlights including network upgrades, wireless infrastructure, email migration office 365, technology support for district, technology plans, and 1:1 initiatives and five year plan.

There was discussion regarding the 1:1 laptops at freshman campus, expanding the 1:1 initiative, online textbook adoption, and the revamped website.

Dr. Carlos H. Rios reported to the Board of Trustees and members of the audience, the purpose of the notice of selection for the 2014-2016 Educator Excellence Innovative Program. Dr. Rios further stated this program will address the recruitment plan for shortage of teachers, teachers' certification, develop teachers' capacity "Master Teacher Academy", career pathways, early literacy, and the program budget summary and timeline.

On September 16, 2013 the Board of Trustees awarded the Buena Vista Elementary Gymnasium project in accordance with RFP #14-04 in the amount not to exceed \$1,646,700. It was noted that the contract amount of \$1,646,700 included a contingency/betterment amount of \$113,700 and that a portion of this amount would be used to fund the fire lane construction costs. To date we have spent \$41,245 of the contingency/betterment amounts on this project. In summary, the funds have been spent as follows:

Contingency/Betterment Balance \$72,455

At this time the contractor has provided our architect with the following cost proposal to complete the remaining portion of the fire lane construction. Due to the cost we are reviewing the feasibility of using a crushed limestone base material to construct the straight away:

Construction of the fire lane straight away with a 2 course chip seal over 6" base \$38,700

Contingency/Betterment Balance \$33,755

We have also received the following cost proposal to pave the remaining portion of the teacher parking lot

that was not in the original scope of work (see attached drawing):

Paving of the remaining teacher parking lot in 5" thick 3000 psi concrete \$48,300

Contingency/Betterment Balance (\$14,545)

If we are to move forward with paving the complete teacher parking lot we will need to add a minimum of \$14,545 to this project. This however, would not allow us to make any other improvements to this project. Therefore, the administration is requesting that we add \$48,300 from available bond funds to the project and leave the \$33,755 in the contingency/betterment to cover any other unexpected expenses.
