### Exhibit A—Log Documenting the Refusal of Entry to or Ejection of an Individual from District Property

**Note to administrator:** Each district will maintain a record of each verbal warning issued prior to written notice of ejection or refusal of entry [see GKA(EXHIBIT)—B)], including the name of the person to whom the warning was issued and the date of issuance. A school administrator, school resource officer, or school district peace officer may refuse entry to or eject a person from any property under the District's control in accordance with Education Code 37.105. Each location from which an individual is ejected or refused entry will be given a copy of the issued notice to be maintained for the duration of the exclusion.

# Exhibit B—Notice of Refusal of Entry to or Ejection of an Individual from District Property

**Note to administrator:** Each district will maintain a record of each verbal warning issued [See GKA(EXHIBIT)—A)] prior to issuing written notice of ejection or refusal of entry, including the name of the person to whom the warning was issued and the date of issuance. A school administrator, school resource officer, or school district peace officer may issue this written notice to refuse entry to or eject a person from any property under the District's control in accordance with Education Code 37.105. Each location from which an individual is ejected or refused entry will be given a copy of the issued notice to be maintained for the duration of the exclusion.

## Exhibit C—Website Notice Regarding the Refusal of Entry to or Ejection of an Individual from District Property

*Note to administrator:* Each district will post this notice on the district's website and on each district campus website.

In accordance with Education Code 37.105, the District has the right to refuse entry to or eject a person from property under the District's control if the person refuses to leave peace-ably upon request and:

- 1. The individual poses a substantial risk of harm to any person, or
- 2. The individual continues to behave in a manner inappropriate for the school setting after having received a verbal or written warning to cease the inappropriate behavior.

A person ejected from or refused entry to property under this provision may appeal this action by filing an appeal under FNG(LOCAL) or GF(LOCAL) and will be permitted to address the Board in person within 90 calendar days of filing the initial complaint, unless the complaint is resolved before reaching the Board. #### Exhibit D—Sample District Notice of Refusal of Future Entry of a Spectator to a UIL-Sanctioned Event

**Note to administrator:** The District is required to refuse attendance at UIL-sanctioned events to any spectator who has committed an offense under Penal Code 22.01(c)(2). The District is not required to provide prior notice.

The University Interscholastic League (UIL) requires the \_\_\_\_\_\_ School District to refuse future attendance at UIL-sanctioned events to any spectator who has committed an offense under Penal Code 22.01(c)(2) (assaulting a sports participant for performing duties or responsibilities or in retaliation for or on account of the performance of a duty or responsibility within the participant's capacity as a sports participant). The District is not required to provide you advanced verbal warning of this refusal and/or ejection. The District may consider all circumstances of each incident when determining the length of suspension of a spectator from future events in activities sanctioned by the UIL.
