# PRIORITY ISSUES FOR THE 88th LEGISLATIVE SESSION

WHEREAS, the Board of Trustees ("Board") of the San Felipe Del Rio Consolidated Independent School District ("District") is authorized by Texas Education Code § 11.151 to govern and oversee the management of the public schools in the District; and

WHEREAS, the Board is authorized by Texas Education Code § 11.1511(b) to seek to establish working relationships with other public entities to make effective use of community resources and to serve the needs of public school students in the community; and

WHEREAS, the Board has developed legislative priorities for the benefit of the district, community, and employees in accordance with these powers.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE SAN FELIPE DEL RIO CONSOLIDATED INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEES:

**RESOLVED,** the Board of Trustees supports legislation that reduces gun violence in coordination with local law enforcement, including legislation to raise the minimum age of purchase from 18 to 21 for semi-automatic, assault style rifles;

**RESOLVED,** the Board of Trustees supports legislation that prioritizes student safety by providing school districts with adequate funding and flexibility to address local needs; and

**RESOLVED**, the Board of Trustees supports legislation and funding to local governments that would expand and improve existing efforts to address substance abuse in schools and the opioid epidemic; and

**RESOLVED**, the Board of Trustees supports legislation that provides funding for safe vehicle and pedestrian routes to schools; and

**RESOLVED**, the Board of Trustees supports legislation that recognizes the disparities in property values and adequately fund and update the state's current facilities programs or create a statewide funding mechanism to assist school districts with reducing the need for additional debt and renovating aging facilities with safe and efficient buildings that are conducive to meeting the needs of students in a modern classroom.
