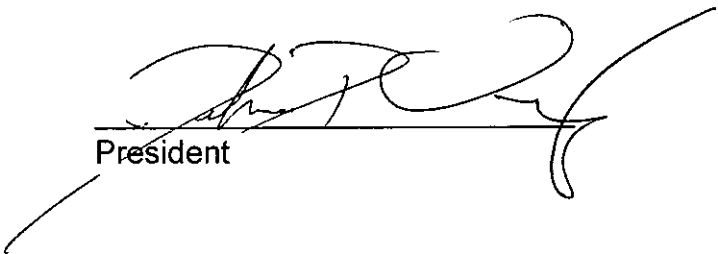

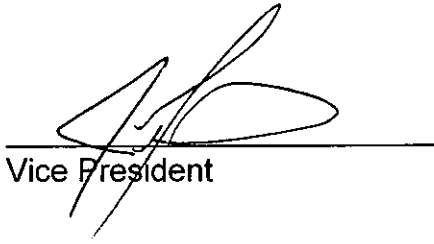

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE SAN FELIPE DEL RIO CONSOLIDATED INDEPENDENT SCHOOL DISTRICT DISAPPROVING THE PROPOSED 2027 OPERATING BUDGET OF THE VAL VERDE COUNTY APPRAISAL DISTRICT.

WHEREAS, pursuant to Section 6.06(a) of the Texas Property Tax Code, the Chief Appraiser of the Val Verde County Appraisal District (VVCAD) submitted a proposed operating budget for the 2027 fiscal year to the Board of Directors of the Val Verde County Appraisal District and to each participating taxing unit; and

WHEREAS, Section 6.06(b) of the Texas Property Tax Code provides that the governing body of a participating taxing unit entitled to vote on the appointment of board members may adopt a resolution disapproving the appraisal district's proposed or adopted budget; and

WHEREAS, the San Felipe Del Rio Consolidated Independent School District is a participating taxing unit in the Val Verde County Appraisal District entitled to vote on the appointment of appraisal district board members and contributes a substantial share of the financial support of the Appraisal District; and

WHEREAS, the Board of Trustees of the San Felipe Del Rio Consolidated Independent School District has reviewed the proposed 2027 Operating Budget for the Val Verde County Appraisal District and has determined that disapproval of said budget is in the best interest of the District and its taxpayers;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE SAN FELIPE DEL RIO CONSOLIDATED INDEPENDENT SCHOOL DISTRICT THAT:

1. **DISAPPROVAL:** The Board of Trustees of the San Felipe Del Rio Consolidated Independent School District hereby formally **DISAPPROVES** the proposed 2027 Operating Budget of the Val Verde County Appraisal District.
2. **REASON(S) FOR DISAPPROVAL:**
 - *Disparity in the employer contributions appraisal district employees would receive compared to school district contributions to district employees*
 - *Disproportionate financial burden placed upon school district taxpayers as largest contributing taxing entity*
3. **TRANSMITTAL:** The Superintendent of Schools or the Secretary of the Board of Trustees is hereby authorized and directed to deliver or transmit a certified copy of this Resolution to the Secretary of the Board of Directors and the Chief Appraiser of the Val Verde County Appraisal District within thirty (30) days of the

Appraisal District's budget adoption, in accordance with Section 6.06(b) of the Texas Property Tax Code.

4. **EFFECTIVE DATE:** This Resolution shall take effect immediately upon its passage and adoption.
