DRESS CODE CODE P. 8 HANDBOOK P. 30

The District's dress code is established to teach grooming, hygiene, prevent disruption, and minimize safety hazards.

Students and parents may determine a student's personal dress and grooming, provided they comply with the following:

- Shall not lead school officials to reasonably believe that such dress or grooming will disrupt, interfere with, disturb, or detract from school activities: and
- Shall not create a health problem or safety hazard for the student or others.

School administrators, with the input of and support of faculty members, have the final decision in determining and enforcing student dress and grooming standards at school and at all school-related activities.



Students should wear garments, shoes, jewelry, accessories and hairstyles that:

Are appropriate size, modest in length, coverage and respectful Reflect a positive image and contribute to a distraction free environment

Outerwear

Dusters, overcoats, trench coats and hoodies with the hood up are not permitted.

Tops/Shirts/Blouses

Must not be excessively tight or revealing, have spagnetti straps or be backless.

Cannot expose underclothing, midsections, torso, back, chest, breasts or cleavage.

Must not contain indecent lewd, offensive, vulgar, or obscene language. Cannot advertise or depict tobacco products, alcoholic beverages, drugs, or any other substance prohibited under board policy.

Pants

Pants/jeans must fit at the waist and avoid showing skin or undergarments through low rise, holes, or bagginess. No holes allowed above mid thigh. Leggings are not permitted.

Shorts/Skirts

Must fit at the waist and avoid showing skin or undergarments. Must fit at mid thigh or longer and not contain rips holes or tears.

Dresses

Must not be excessively tight or revealing, have spaghetti straps or be backless, low cut, expose underclothing, midsection, back, torso, chest, breasts or cleavage. Must fit at mid thigh or lower

Shoes

Must not distract/interfere with learning environment or present health or safety hazard.

House slippers, flip flops of any kind are not allowed.

Steel toed boots not allowed, however, safety shoes are permitted in appropriate setting

Hair and Makeup

Hair must be well-groomed, neat and clean, and not cover the face. Hairstyle, hair color, and makeup must not distract from the learning and school environment.

Other

Underclothing must be appropriate.

All pajamas/loungewear are prohibited.

Jewelry, piercings, or accessories (including wallet chains) must not distract from the learning and school environment.

Sunglasses are not to be worn inside of school buildings.

Skateboards are not allowed.

Any clothing or accessories with gang colors, symbols, or emblems are prohibited.

Blankets of any kind are prohibitied.
