Business and Finance

A. Consideration to approve the 2016-2017 District Compensation Plans to include Job Classifications and Salary Schedules based on the TASB Maximum Value by Pay Grade and Lane, plus the Stipends, to include the longevity stipends of .47% of the base pay for the employees that exceed the maximum value by pay grade and lane, as well as the Substitute and Temporary/Extra Duty, and Summer School schedules. The 2016-2017 **Debt Service** is budgeted with estimated revenue and expenditures of **\$4,118,520.00**.

The 2016-2017 Food Service Budget has estimated revenue of \$5,870,420.50 estimated expenditure of \$6,108,461.73 with an estimated deficit of \$238,041.23.

The 2016-2017 total Combined District Official Budget has estimated revenue of \$92,566,072.67; estimated expenditure of \$92,804,113.90.
